Schedule to Terms & Conditions of entry

Terms & Conditions of entry

Interpretation

- Information on how to enter and prize details form part of these terms & conditions (Terms of Entry). The Terms must be read in conjunction with the above Schedule to Terms & Conditions of entry (Schedule). The Schedule defines the terminology used in these Terms of Entry and in the Schedule. Where there is any inconsistency between these Terms and the Schedule, the Schedule prevails. Participation in this Promotion is deemed acceptance to be bound by these Terms of Entry.
- 2. Entry is open only to Eligible Entrants who satisfy the Method of Entry. Prize

- 22. The Promoter may in its absolute discretion not accept a particular entry, may disqualify an entry, or cancel the entire Promotion at any time without giving reasons and without liability to any entrants. Without limiting this the Promoter reserves the right to verify the validity of entries, prize claims and entrants and to disqualify any entrant who submits an entry or prize claim that is misleading or not in accordance with these Terms of Entry or who manipulates or tampers with the entry process. In the event that a winner breaches these Terms of Entry, the winner will forfeit the prize in whole and no substitute will be offered. The Entrant consents to the collection of their personal information for the purposes of the Promotion.
- 26. The Promotion and these Terms of Entry will be governed by the law of the Australian Capital Territory. Entrants accept the non-exclusive jurisdiction of courts and tribunals of that Territory in connection with disputes concerning the Promotion.
